Submitted papers must be written in English and must not have been previously published or simultaneously submitted for publication elsewhere.

Authors are expected to follow the conference paper template provided on the official website when preparing their submissions. Each author may submit a maximum of two papers; however, only one paper may be considered for publication.

To participate in the conference, authors may submit either an abstract or a full paper and are invited to complete the Registration Form. The completed form and, where applicable, the full manuscript should be sent to [conferintaEFM@icfm.ro](mailto:conferintaEFM@icfm.ro).
