Authors are expected to adhere to the conference paper template provided on the official website when preparing their submissions. Each author may participate with up to two papers; however, only one may be selected for publication.

The abstract and authors' details should be submitted using the Registration Form. Authors are kindly invited to send both the completed form and their manuscript electronically to conferintaEFM@icfm.ro.

Full scientific articles may be published in the *Journal of Financial and Monetary Economics*, indexed in RePEc (EconPapers and IDEAS), JGATE and ECONBIZ.

In partnership with the *FinTech* journal, the 13<sup>th</sup> Annual International Scientific Conference - FME 2025 will select the best paper for submission to the special issue *Financial Technology and Strategic Al Integration in FinTech*. The editorial team will cover the publication fee.
